# WHO IS THE CENTRAL FLORIDA EXPRESSWAY AUTHORITY (CFX)?

- Florida Legislators have pushed for a regional expressway system in central Florida for several years, recognizing that roads do not stop at county borders.
- CFX has a Board of Directors made up of a majority of locally elected officials, strong ethics policies and the authority to consider other modes of transportation within the right-of-way of the expressway system.
- CFX is a local independent special district agency of the state with a staff of 58 people; 98% privatized

# SENATE BILL 230

- Signed into law by Gov. Scott on June 20, 2014.
- Eliminated the Orlando-Orange County Expressway Authority (OOCEA) and created the new Central Florida Expressway Authority (CFX).
- All assets, liabilities, duties, responsibilities and obligations of OOCEA transfer to the new Central Florida Expressway Authority.





# REGIONAL AUTHORITY

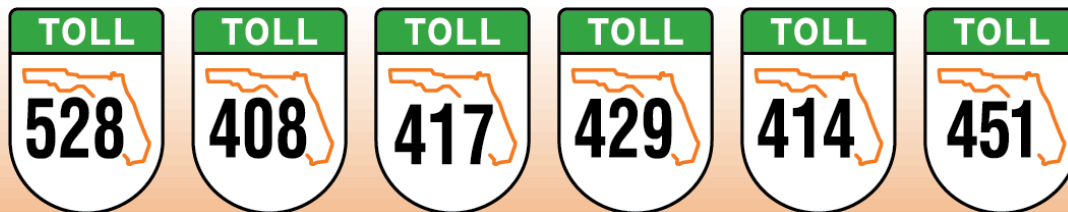
- Agency jurisdiction includes Lake, Osceola, Orange and Seminole Counties.
- There are no expressway authorities in Seminole County or Lake County.
- Osceola County Expressway Authority (OCX) was established by the Florida legislature in 2010. OCX will become part of CFX sometime after 2018 when financial milestones outlined in the law have been achieved on current ongoing projects.





# CFX SYSTEM

- CFX inherits the system created by OOCEA.
- Florida's Turnpike and the FDOT continue to own and operate their roadways in central Florida.
- CFX will be responsible for building new facilities in Orange, Lake, Seminole and Osceola Counties.

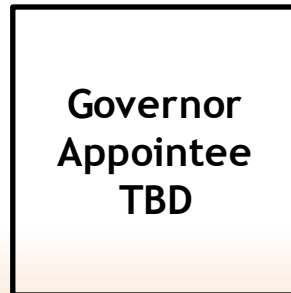

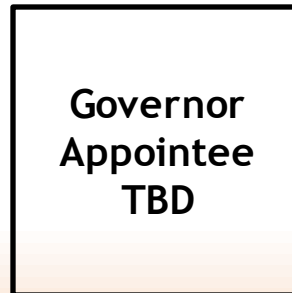

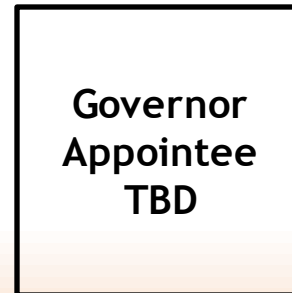
